- 7. That the school shall strictly abide by the provisions of Section 10(i) of the Delhi School Education Act & Rules, 1973.
- That the minclosent in section shall not exceed the number of students calculated @ 12 Sq. feet per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of sections should not exceed the number of existing class rooms of proper size in the school.
